## **Converted Foreign-Registered Vehicle**

A vehicle owner must present the **Declaration of Conversion** and related **Suitably Qualified Individual declaration** to the NCTS when declaring a vehicle of this type for registration.

- Please see **www.ncts.ie** for documents which must be brought to the NCTS when presenting a vehicle for registration.
- In addition, the total cost of conversion in Euros including VAT must be supported with a list of invoices / receipts showing dates and amounts.

## **Converted Irish-Registered Vehicle**

## Declaration to Revenue is required in the following cases

- (1) Declaration is required if the Vehicle Registration Certificate at J1 shows "B" or "C" or "D" or is blank, and:
  - seating positions have been added and the new total including the driver is nine seating positions or less;

or

had ten seating positions or more, seating positions have been removed and the new total including the driver is nine seating positions or less;

or

- converted to motor caravan.
- (2) Declaration is also required if the vehicle has been converted to an EU Category N1 vehicle, with more than one row of seats.

# Only if (1) or (2) above is the case, the vehicle owner must submit the Declaration of Conversion and the related Suitably Qualified Individual declaration, and other supporting documents to: Revenue's MyEnquiries portal.

#### Declarations should be submitted together with the following Supporting Documents:

- a copy of the Vehicle Registration Certificate (both sides),
- invoice(s) showing the costs of conversion,
- where a vehicle is a Category A vehicle, or is being converted to a Category A vehicle evidence of NOx must be provided,
- in the case of a vehicle that is being converted to an EU Category N1 vehicle with more than one row of seats, measurements and photographs must be submitted as set out in 'Appendix 1: Measurements of vehicle converted to N1 with more than one row of seats',
- in the case of a Motor Caravan, photographs showing the full interior, at least one of which should be taken from the front
  of the living area looking rearward and one from the rear of the living areas looking forward such that they provide a good
  overview of the layout of the living accommodation. At least three photographs should be of the exterior one of which also
  includes the registration plate of the vehicle. A maximum of 15 photographs in total should be submitted.

## Appendix 1: Measurements of vehicle converted to N1 with more than one row of seats

In cases where a vehicle is converted to EU Category N1 with more than one row of seats, measurements and photographs must be submitted as detailed below. Revenue will not process the declaration of conversion unless fully satisfied that the measurements provided are accurate and that the vehicle meets the relevant criteria for an N1 vehicle, as set out in **Annex 1 of Regulation (EU) 2018/858**.

This information is required solely to assist Revenue with processing the conversion application. It remains the responsibility of the vehicle owner to ensure that a Suitably Qualified Individual certifies that the converted vehicle complies with all relevant standards and regulations.

#### **Rear Loading Aperture Dimensions:**

Please provide the following dimensions for the rear loading aperture of the converted vehicle. Measurements must be taken by a Suitably Qualified Individual. The terms 'height of the loading aperture' and 'surface of the loading aperture' are defined in Annex 1 of Regulation (EU) 2018/858. The term 'aperture width' means the clear unobstructed width of the aperture.
